RE: Exterior Changes to Homes

<u>All</u> exterior changes to homes must receive <u>prior</u> approval by the Architectural Review Committee (ARC). This includes, but is not limited to, color changes, pavers, doors, fences and other exterior changes you may consider making to your home.

The committee will work as quickly as possible to review your request and will provide a letter to you with the results of the review. *Please allow TWO weeks for the approval process*. Changes should <u>NOT</u> be made prior to receipt of a letter from the ARC approving your request. Should you complete the work prior to approval, the ARC has the right to require that you <u>undo/redo the work as approved by the ARC</u>.

An ARC application form is provided on the following page. Your application must be distributed (emailed or hand-delivered), one to each of the nine (9) members of the ARC. To email your form and any supporting documentation, use the group email address oakknollestatesarc@gmail.com. If you need to hand-deliver the form, please email the ARC email address with your request and the home addresses will be provided to you.

Below are the requirements for submitting an ARC application to paint the exterior of your home. Requests that do not meet **ALL** these requirements **WILL NOT BE** reviewed:

Exterior Painting

- Prior to submitting your application, paint at least a 12" x 12" sample* of your base color on the FRONT of your home. Paint trim sample on the trim of your house next to the base color sample. Paint samples of your garage, front door and fascia colors and identify on masking tape which color applies to which item.
 - *The ARC may request that you paint a larger sample.
- Your application to paint MUST include the paint brand and colors you will be using for each area. Example: Behr "Cloud White" for trim, Behr "Sage" for base, etc. and include which color will be used for base, trim, garage door, front door and fascia. Applications without this information will not be reviewed.
- Do NOT paint until you receive an official approval letter on behalf of the ARC.
- Painting must be done by a professional.
